I understand that I am required to read carefully and sign a Release of Liability and Assumption of Risk form before the Nomad Adventure Sdn Bhd, the race organizer, their sponsors, their agent(s) and/or their employee(s) will accept a deposit confirming my reservation for myself for the Eco X-Treme & Eco X-Ultra Sprint November 2004 on November 23rd, 2004 at Kuala Kubu Baru, Selangor.

I understand that the race is an adventure sport and may involve some risky activities. I have been advised by Nomad Adventure Sdn Bhd to obtain a Personal Accident Insurance, which is commercially available.

I am aware that adventure sports involve inherent risks of illness, injury, death and/or loss or damage of property, which may be caused by negligence, forces of nature and other causes known or unknown. I recognize that such risks are present at any time, before, during and after the race. I am also aware that medical services or facilities may not be readily available during the race.

IN CONSIDERATION OF, and as part of the agreement for the opportunity to participate in the race, the activities, services and food arranged for me (if any) by Nomad Adventure Sdn Bhd, I (Releasor) agree to HOLD HARMLESS and RELEASE Nomad Adventure Sdn Bhd, it's sponsors, officers, owners, directors, employees, agents, associates and suppliers (Releasees) from and for all accidents, claims, losses, damages and liabilities (including without limitation, death, liability, injury, loss/damage to the Releasor and their property) which might occur during the race, including without limitation to those losses arising out of the strict liability or the joint or concurrent passive negligence of the Releasees. I expressly assume any and all such risks with respect to the race and the activities and circumstances described herein and pledge and undertake not to sue the Releasees or any one or more of them on account of any such losses, claims, costs, liabilities or damages, and further, I agree that the foregoing shall be binding upon me personally and my family, as well as upon my estate, heirs and personal representatives. I also agree that this agreement shall be governed by Malaysian Law.
